

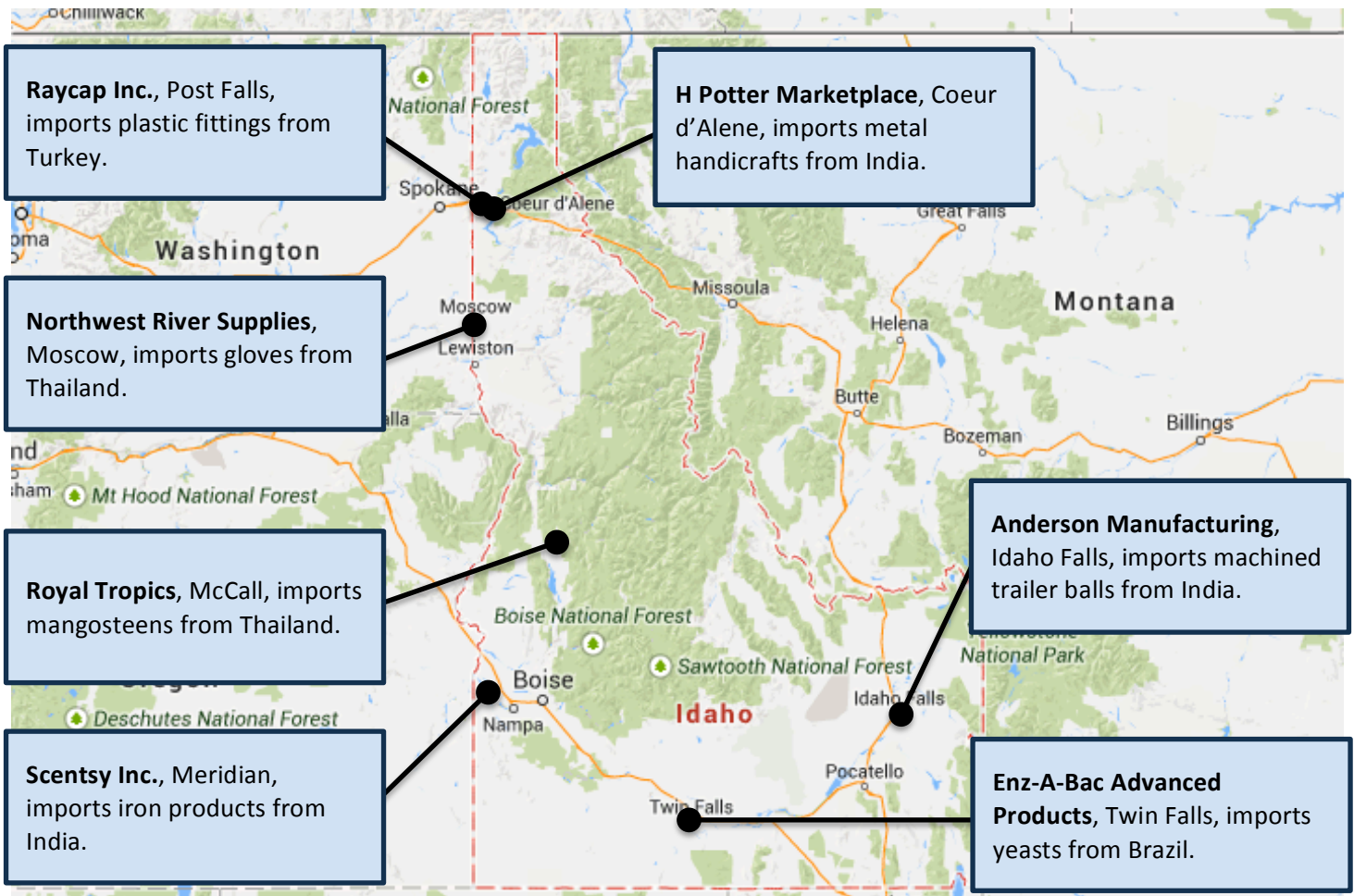


# GSP MATTERS FOR IDAHO

The Generalized System of Preferences (GSP) program benefits American companies and workers by cutting tariffs (i.e., taxes) on certain products sourced from developing countries. In 2016, GSP saved American companies \$729 million, including \$645,000 in waived tariffs on imports into Idaho. However, GSP will expire and companies in Idaho will face higher taxes unless Congress passes new legislation to renew GSP before December 31, 2017.

## IDAHO COMPANIES IMPORTING UNDER GSP

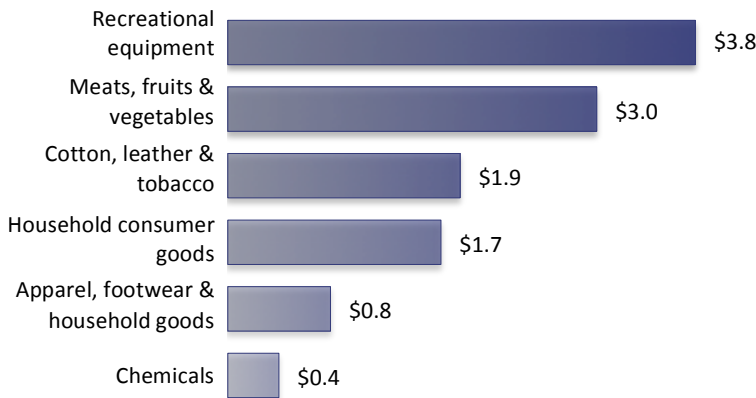

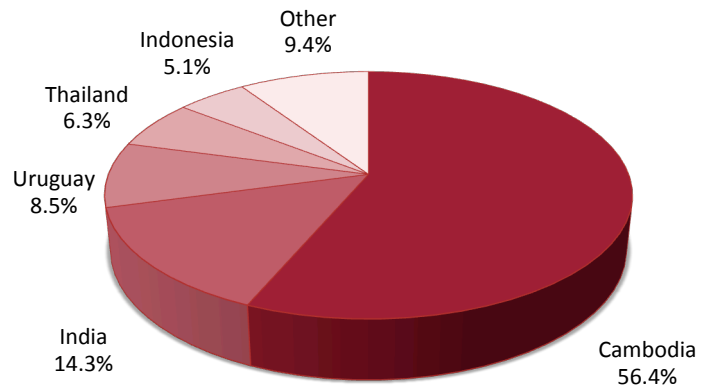
# IDAHO'S IMPORTS UNDER GSP

GSP eliminates tariffs on about 3,500 products. Most Idaho imports under GSP are raw materials and industrial goods whose duty-free treatment helps American companies remain competitive. About 79 percent of Idaho's tax savings from GSP come on imports from three countries: Cambodia, India, and Uruguay.

## GSP EXPIRATION HURTS AMERICAN COMPANIES AND WORKERS

The GSP program has a long history of expirations and retroactive renewals. Yet recent surveys show how damaging the expirations – and positive the renewals – can be for companies and workers that rely on GSP.

Impacts on American Companies	
GSP Expired <sup>A</sup>	GSP Renewed <sup>B</sup>
Laid Off Workers / Delayed New Hires <b>13% / 44%</b>	Hired New Employees <b>46%</b>
Delayed Capital Expenditures <b>40%</b>	Made New Capital Investments <b>41%</b>
Cut Employee Wages or Benefits <b>22%</b>	Provided New (or Reinstated) Benefits <b>23%</b>

GSP saved Idaho companies about \$3.1 million from 2011 to 2016. However, about \$2.0 million of that came while GSP was expired. So companies paid the taxes without knowing when – or if – Congress would renew GSP retroactively.

When GSP expires, the uncertainty causes many companies to take drastic steps, from laying off workers to delaying investments to cutting benefits, stunting growth and harming workers.

Only after GSP was renewed could companies start growing and investing again in their workers and communities. Even then, companies often wait over a year to receive all of their refunds.
